i. Constitutional Amendments

Proposed amendments to the AUJS Constitution must be emailed to the Returning Officer no later than 6pm on Sunday 27th August 2023.

No proposed amendments can be accepted after this date, so that the Returning Officer may provide 14 days' notice to all constituent organisations, per Point 16.1 of the Constitution.

ii. Nominations

Nomination forms for election must be submitted to the Returning Officer by 6pm on Sunday 3 September. The acceptance of nominations after this date will be at the discretion of the Returning Officer. To nominate for a position, please [fill out this form](#). Once you have completed the form, a document will be sent to you, your proposer and seconder to sign. Please make sure this is completed by the deadline.

- Conferences Coordinator
- Leadership and Development Coordinator

In line with section **8.1.1** of the constitution, all nominees must be members of the Union and must be proposed and seconded by members of the Union.

iiii. Voting

The AUJS Constitution outlines voting and electoral procedures for general meetings, including the applicable Standing Orders, attached in Appendix C. The number of votes calculated are based on membership numbers as of Friday 18th of August 2023..
